TOWN OF ROSENDALE TOWN BOARD MEETING June 1, 2022

Supervisor Walsh called the meeting to order at 6:30PM and entered Executive Session to discuss the employment of a particular person. Supervisor Walsh made a motion that the Town Board of the Town of Rosendale hire Amanda Long as Temporary Recreation Specialist at \$13.75 per hour for up to 37.5 hours per week effective 6-20-2022 thru 8-19-2022.
