**RESOLUTION: FRANCHISE RENEWAL AGREEMENT WITH CHARTER COMMUNICATIONS/SPECTRUM**

**WHEREAS**, an application has been duly made to the Board of the Town of Rosendale, County of Ulster, New York, by Spectrum Northeast, LLC, an indirect subsidiary of Charter Communications, Inc. (“Charter”), a limited liability company organized and existing in good standing under the laws of State of Delaware doing business at 2604 Seneca Avenue, Niagara Falls, NY 14305, for the approval of a renewal agreement for Charter's cable television franchise for ten (10) years commencing with the date of approval by the Public Service Commission; and

**WHEREAS**, the franchise renewal agreement would bring the franchise into conformity with certain provisions of the Federal Cable Communications Policy Act of 1984, as amended, and certain court rulings; and

**WHEREAS**, a public hearing was held in the Town of Rosendale, New York on May 7, 2025 at 6 P.M. and notice of the hearing was published in the Daily Freeman on April 29, 2025.

**NOW, THEREFORE BE IT RESOLVED** that the Town Board of the Town of Rosendale finds:

1. Spectrum Northeast, LLC has substantially complied with the material terms and conditions of its existing franchise and with applicable law; and
2. Spectrum Northeast, LLC has the financial, legal and technical ability to provide these services, facilities and equipment as set forth in its proposal attached; and
3. Spectrum Northeast, LLC can reasonably meet the future cable-related community needs and interests, taking into account the cost of meeting such needs and interests; and

**BE IT FURTHER RESOLVED** that the Town Board of the Town of Rosendale hereby grants the cable television franchise of Spectrum Northeast, LLC and the Town of Rosendale for ten (10) years commencing with the date of approval by the Public Service Commission and expiring ten (10) years; hence; and

**BE IT FURTHER RESOLVED** that the Town Board of the Town of Rosendale hereby confirms acceptance of this franchise renewal agreement.
