Public Input/Community Events: Councilmember Wykoff said the Rosendale Street Festival is July 19th and 20th. Volunteers are still needed and can sign up at rosendalestreetfestival.org. The Street Festival was also awarded a \$2,000.00 grant from the County for a green the scene and helping them with zero waste.

Supervisor Walsh made a motion to approve June 4th minutes as amended, 2nd by Councilmember Wykoff. ROLL VOTE: 3 YES.

Committee Reports

Recreation (Councilmember Sweeney): Report by Supervisor Walsh

Swim lessons are going great, and the evening swimming lessons are a hit.

Aquaoga swim has started off great and 30 people were in attendance the first day.

Artistic swimming has 7 people that are signed up currently.

There has been good pool membership enrollment and people are still getting memberships and sold 145 to date.

The daily numbers of visitors to the pool seemed a little low to Dorene, she believes the free swimming and bussing to the County Pool has something to do with it. Weekends are busier.

Youth (Councilmember Sweeney): Report by Supervisor Walsh

Summer Camp is in full swing and is keeping the Youth Department very busy with almost 100 kids a day. Session 2 ends this week.

Kids Night out will be July 31st from 6pm-9pm. It will be a pool, pizza and dance party. The cost is \$20 per child and open to youth ages 5-14. Registration will be at the pool. Youth Revenue for June was \$9,165.00.

There is no Youth Commission meeting for the month of July, the next meeting will be August 4th at 7:00pm at the Youth Center.

Elder Assistance (Councilmember Sweney): Report by Supervisor Walsh
The Committee would like to explore the idea of appointing a Senior Poet Laureate in
Rosendale.

Tax Collector (Councilmember Sweeney): Report by Supervisor Walsh The 2025 tax season is closed. The account has been paid, and the books have been turned over to the County.

If any residents still owes taxes at this point and wants to pay them, they will have to call the Ulster County Department of Finance.

Food Pantry (Councilmember Sweeney): Report by Supervisor Walsh
They are looking for volunteers with trucks for food pick up. Also, anyone who is looking
for things to do and would like to volunteer to work in the pantry as a regular or a sub, that
would be great and very helpful. They can contact Deborah Checchia or stop by the food

pantry during open hours.

Planning (Councilman Cassidy):

Engineers for Williams Lake are expected to submit documents for final plat approval of the major subdivision at the July meeting.

A Public hearing for Six Bells was opened but their representative didn't show up. The Planning Board decided to keep the meeting open for another month.

A Public hearing on the Purvis and Teed major subdivision on Rt 213 was held.

The ADU for the single-family home was given preliminary approval with some conditions (building permit, and road maintenance agreement).

Dave Plante provided feedback to the Planning Board on the camping law and amendment to the STR law, which will be discussed tonight.

ZBA (Councilman Cassidy):

The meeting was cancelled because of lack of a quorum.

Fire Marshal (Councilman Cassidy):

There were two fire safety inspections, three fire re-inspections and one property maintenance inspection.

Building (Councilman Cassidy):

There were 41 fees collected for a variety of permits and applications totaling \$8,624.00.

Justice (Councilman Cassidy):

As of 6/30/25:

Judge Pape's fine account has \$6,765.00 and bail account has \$13,850.00 (same as May) Judge Ragucci's fine account has \$7041.00 bail account has \$821.00.

Town Clerk (Councilman Cassidy):

There were 30 dog licenses sold and fees collected were \$230.00.

Building Department fees turned into the Town Clerk was \$8,624.

56 Landfill permits were issued for a total of \$1,900.00.

Miscellaneous fees taken in were \$716.10.

Total collected and remitted to the Supervisor for General Fund was \$3,122.03 plus the \$8624 from the Building Department for a total of \$11,736.03.

Town Historian (Councilman Cassidy):

The museum accepted a showcase from Ms.Wanita Yarder.

Volunteers with experience in setting up museums are encouraged to contact Bill and complete a volunteer application form.

Environmental (Councilmember Wykoff):

They want to move their meeting date and time to the 2nd Thursday of every month from 6:00 PM – 7:30 PM.

The Plastic People film was a success and are looking for new films.

The community compost was narrowed down to 2 possible options.

RMC (Councilmember Wykoff):

There is a new carpeting in M-1 and thanked Joe la Fera.

Joe has met with a new contractor about a sidewalk on Marbletown's side and fixing the blacktop and also waiting on a second quote.

Joe is also waiting for a quote on the gym floor.

Transfer station (Councilmember Wykoff):

They took in \$9,060.20 for June and \$1,900.00 for permits.

Economic (Councilmember Wykoff):

They are still looking for members as they need 5 and currently have 2, with someone on the agenda for tonight.
